



2011 OREGON JUDICIAL DEPARTMENT RULE PUBLICATIONS

- 2011 Oregon Rules of Appellate Procedure (ORAP)**, effective January 1, 2011. This set incorporates all previous revisions. These rules apply to proceedings in the Supreme Court and Court of Appeals. The cost is \$13/copy and tab sets are available for \$6.50.
- 2011 Supplementary Local Rules (SLR)**, effective February 1, 2011. Each set is a complete compilation by county of locally adopted rules that supplement the Uniform Trial Court Rules (UTCR). The cost is \$45.50/set. Individual rules for a specific county must be purchased directly from the county trial court administrator.
- 2011 Uniform Trial Court Rules (UTCR)**, effective August 1, 2011. This is a complete compilation of mandatory rules governing the Oregon trial courts. The cost is \$19.50/copy.
- 2002 Oregon Appellate Courts Style Manual**. This manual, adopted by the Oregon Supreme Court, Court of Appeals, and Tax Court, standardizes the form for publication of the opinions issued by those courts. It is a useful guide for other documents filed in the appellate courts. The cost is \$19.50/copy.

The latest volumes issued are 349 Or for the Supreme Court, 240 Or App for the Court of Appeals, and 18 OTR for the Tax Court.

Oregon Appellate Courts Media Releases. Written synopses, published weekly, of selected cases issued by the Supreme Court and Court of Appeals, which also include notice of public meetings and other matters. The cost is \$81.25/6 mos.
